Our Lead Operator was stationed next to one of the RBC units, where we had removed the end cover to reveal the rotating media and provide guests with a clear view of the process. Our Operations Manager remained near the Odor Control System to explain the equipment and answer any questions from visitors.

Following the plant tours and vendor expo, a luncheon was held, followed by EPWPCOA's quarterly meeting. Welcoming remarks were delivered by Operations Manager, Eddie Mongan before handing it over to Executive Director Brent Wagner for his presentation. During the meeting Brent and Eddie were honored to accept a plaque from EPWPCOA in recognition of the Authority's role as event host. This event was a great way to showcase the hard work and effort put forth by Authority staff.



### **Beware of Stormwater Pollutants**

Please be aware of what enters stormwater inlets, as certain materials can cause significant harm. Stormwater does not go through our wastewater treatment facility, but it is still subject to DEP and EPA testing standards.

While pet waste might appear harmless, it can lead to elevated fecal coliform levels. Additionally, items such as trash, soaps, oils, medications, yard debris, and litter can build up, block pipes, and negatively impact aquatic life in nearby streams and rivers.

## **Keep Cooking Grease Out of Your Sink Drain**

Pouring cooking grease down the drain is one of the most damaging things you can do to a wastewater system. It can clog sewer mains and block your home's plumbing, potentially leading to expensive repairs. Hot oil, in particular, can also harm the plastic pipes



often found beneath sinks. The image below, taken by our sewer camera, shows a pipe that is nearly 75% blocked by built-up cooking grease.

Please follow the recommended disposal methods. Beyond causing blockages, excessive

grease also requires us to use more grease emulsifier, which increases overall treatment costs.
